It is with great enthusiasm that we would like to welcome you to the ESET UK Affiliate Programme with CJ.

In this welcome pack, you will find all you need to know about being a Publisher on the programme.

We want to equip you with the tools needed to drive revenue and to make an impact on the programme, including creating links and using available creative assets.



How to Sign Up

Click <u>HERE</u> to sign up.

Follow these simple steps:

- If you have a CJ account, then log in to join the programme.
- If you're new to the CJ network, please follow the below steps for signing up to CJ:
 - 1. Fill in all fields completely and correctly.
 - 2. Choose a password that is at least eight characters long and includes a combination of letters, numbers and/or special characters, and does not contain your username.
 - 3. After the registration, you will receive a verification email to create your own CJ Publisher Account.
 - 4. Click on the "Create My CJ Publisher Account" button in the verification email and you will be taken to a form to accept legal agreements. The two shorter agreements are simple checkboxes (age certification and certification of authority) and the three longer agreements are in collapsible sections (PSA, software and privacy policies). You must scroll through and explicitly accept all five agreements before you can continue.



How to Sign Up

Your unique publisher CID (company ID) is now created, but at this point it is not visible to Advertisers. You can browse Advertisers but can not be seen by them or interact with them. Please always have your CID at hand when contacting CJ Support. You will now access the Publisher onboarding checklist.



CJ Publisher Onboarding Checklist

You are required to complete the following steps while in 'setup mode' in order to earn commissions and get pay-outs:

- Set up at least one user
- Complete network profile (programme description)
- Set up at least one promotional property
- Provide company details (company name, address, phone etc.)
- Provide tax info
- Provide bank account info
- Answer some screener questions



CJ Account Setup

- 1. Click on "Get Started" on any of the steps in the setup checklist a feature tour will launch.
- 2. The feature tour walks you through the steps of completing each task. This will familiarise you with the platform, in addition to completing the task.
- 3. At the end of each task, you will be prompted to start the next task or return to the checklist.
- 4. Once details are satisfactorily completed, the "Activate Account" button will become available.
- 5. On clicking this button, your CID status will be changed from "set up" to "active". You are now able to apply to and receive offers from Advertisers.
- 6. If you entered via a branded sign-up experience, an application will be sent through to the Advertiser in question at this time.
- 7. To accept a partnership offer, please go to "Advertisers" \rightarrow "Pending Offers".

Affiliate Links

How to generate links:

- 1. Login to the CJ Account Manager
- 2. Go to "Links" \rightarrow "Search"
- 3. Enter "ESET" in the search field and select the relevant programme
- 4. Choose link type and select search
- 5. Click on the name of the link type you want
- 6. Select option "Get Code"
- 7. From the website dropdown, select the correct PID \rightarrow update code
- 8. Choose "Click URL"
- 9. You now have your ESET UK affiliate link with the CJ tracking appended to it

Please note that the update button will give you several different links, as we track through four different servers.



Creative Assets

These links and many more can be found on the CJ platform. Just follow these steps:

- Connect to your CJ Publisher Account
- On the top bar, choose "Links" → "Search"
- Type the Advertiser name
- Adjust the filters to select the banners
- Get your tracking html









When Will I Get Paid?

What does transaction status mean?

- New: Transactions are shown as "new" until validated. Validation occurs on the 28th of the month, one month after check out.
- Locked: Publisher commission has been confirmed. If locked and the publisher commission is o or reversed out (if already paid), this might refer to the non-commissionable products / cancelled / returned orders.
- Closed: Transactions are moved to "closed" once publishers have received payment.



When Will I Get Paid?

You can view the check out date in the CJ Account Manager within the Transaction Report. Choose: "Reports" \rightarrow "Transaction" in the top bar. Once the report has been run, scroll to the right and locate "End Date Time".

- Commission is paid out only on completed orders.
- Common reasons you have not been paid or partially paid:
 - 1. The purchased product is not a commissionable one.
 - 2. The order has been cancelled.
 - 3. The order has been partially returned.

Fully functional website with quality content

- 1. You should ideally have a working, top-level domain with content focussed on a UKbased audience.
- 2. Your domain shouldn't contain registered trademark "ESET" or any misspellings or content that would be confusingly similar to the official eset.com/uk website.
- 3. We encourage providing authentic, high-quality content, such as product reviews and online security tips & tricks that resonate with your audience.
- 4. Your website must be free of illegal, offensive, questionable or low-quality content or links to sites containing such.
- 5. Place ESET text links or banners on your website, or in your online marketing communications, and start earning your commission.



Official affiliate artwork

- 1. Please use the affiliate text links and official affiliate banners from the programme.
- 2. Do not alter them we can offer you some pre-made links and banners free of charge.
- 3. Keep the wording and artwork the same as in the ESET promotion.
- 4. Use coupons and promotional codes that are provided exclusively through the affiliate programme.
- 5. ESET names and logos may not be used in any way without prior written permission from ESET.



Paid Search

- 1. You may use paid search to promote ESET products, but restrictions must be followed.
- 2. You are not permitted to bid on ESET's trademarked terms or any variations or common misspellings, including: ESET, NOD32, ESET NOD32, NOD 32, Smart Security, Deslock and ThreatSense. Failure to abide will result in termination from the programme.
- Don't use any actual coupon code in any part of a search ad including the headline and ad copy (i.e. ESET10OFF)
- 4. Positioning on renewal products is prohibited in search engine marketing and affiliate landing pages.



Social Media & Email Marketing

- You have various options for spreading the word about ESET with your audience. Please keeps us in the loop prior to any social media or email marketing activity. This must be pre-approved by the Affiliate Manager before being issued.
- 2. Don't promote ESET products using spam or unsolicited commercial email.
- 3. Don't forget that any marketing communication shall be targeted for UK traffic only, as we can not grant commissions on purchases outside of the UK territory.



How to Pull Reports

Useful Reports are found in your CJ Account under "Reports". For period-over-period reporting and data visualisation, click into "Insights".

Performance Report

- Helps you see how your performance is trending.
- You can choose your performance metric from the dropdown under "Performance By".

Transaction Report

- Helps you look up specific transactions.
- You can also pull reports with all transactions for a certain time period.

Good to Know

• Clicking on the leaflet allows you to add more metrics to your report. The pop up that appears has many drop-down lists, so please explore what metrics are available for you here.
